Manuscript publication is a requirement for an oral presentation to be given at Titanium 2019. The authors should provide a document with a maximum length of 20000 characters (including spaces) for contributed presentations or posters and 25000 characters for plenary sessions and keynote sessions. The proceeding should be submitted online using the dedicated platform.

Manuscript should be written in English. Proof-reading by fluent English speakers is recommended for non-fluent English speakers. Submitted manuscripts should be formatted by the authors according to the guidelines of the present document. Its format serves as an example.

Please note that the authors have to return a filled Publication Right form available on the submission portal. Deadline for reception of the manuscript and publication form is 1<sup>st</sup> of May 2019. At this date, texts would be then reviewed for publication. Comments could be sent by reviewers to authors in order to modify or precise some data in the manuscript.

#### Title and authors affiliations

General guidelines

The title of the manuscript should be the same as submitted for the presentation. The complete list of authors should be given under the title with the corresponding affiliations. The corresponding author and an email address should be indicated as well.

## Abstract

General guidelines

An abstract containing a summary of the content of the article should be provided with a maximum length of 200 words.

**Format** 

Font: Times New Roman / Size: 10

The text should be justified.

The quality of the digital images should be at least 300 dpi for figures.

## Main body

General guidelines

Introduction, conclusion and references sections are mandatory. A typical structure would be: Abstract, 1. Introduction, 2. Material and experiments, 3. Results, 4. Discussion, 5. Conclusion, 6. Acknowledgements, 7. References

Each figure and table must be given an associated caption. Captions should be centred above the tables and centered beneath the figures. Figures should be placed close to the paragraph where they are first referred to. Reproduction of a figure or table from another publication must be noticed and the permission for reproduction must be obtained. Equations should be centered and numbered (on the right-hand-side).

**Format** 

Section headers:

Font: Times New Roman / Size: 12 / Bold / Underlined

Sub-section headers (if any):

Font: Times New Roman / Size: 10 / Italic

Text:

Font: Times New Roman / Size: 10

Figure captions:

Font: Times New Roman / Size: 9 / Bold / Centered

One line should be slipped between sections and the text should be justified.

### **References**

General guidelines

References should be referred to using numbers in brackets next to the relevant statements. Typical reference designation is as follows:
